**AMENDMENT TO CLARIFY THE RELIEF SOUGHT**


**TO THE HONORABLE COMMISSIONERS OF THE BOARD OF PUBLIC UTILITIES:**

Petitioners hereby submit this amendment clarifying the relief sought in the above-captioned petition, filed on April 30, 2014. Petitioners seek for the New Jersey Board of Public Utilities to adjudicate its April 30, 2014 petition as a petition for rulemaking to be processed pursuant to the provisions of N.J.A.C. 1:30-4 *et seq.* For the reasons described in petition, Petitioners request that the BPU exercises its rulemaking authority to limit the rates, terms, and conditions imposed by intrastate inmate calling service (ICS) providers to “just and reasonable rates”, not to exceed \$0.05 per minute, for incarcerated people, detainees, and their families in both state and county prisons and jails. Petitioners request that the BPU hold regional public hearings to gather further public input on this proposed rulemaking. The BPU should take into account the existence of technology and the rates available in other states when setting just and reasonable rates that reflect the costs of providing phone services in New Jersey prisons and jails. Just and reasonable rates should not exceed the approximate rate for all calls from neighboring state prisons.

Petitioners respectfully request the Board begin the rulemaking process for considering its April 30, 2014 petition, as amended herein.
