Employment for those between the ages of 16 and 18 is limited to positions where job duties and work schedules are permissible by law.

NOTE: All lifeguard applicants for the State Park Service jobs are required to be tested by the Division of Parks and Forestry before an interview is granted. **The application deadline for all positions is March 1, 2015.**
