Reservations for overnight facilities can be made up to 11 months in advance in person, by mail or by telephone (during normal business hours) using a credit card.

Payment in full must be made at the time of reservation. Please refer to the chart on the back to determine the total fee. Payment can be made by cash, check, money order or credit card. Checks and money orders are to be made payable to "Treasurer, State of New Jersey". Reservations are non-transferable.

Only one reservation change is permitted prior to occupancy. If campsite reservations are cancelled 24 hours prior to occupancy, your payment is refundable minus a \$40/resident \$50/non-resident cancellation fee or 2 nights stay, whichever is less. If other overnight facility reservations are cancelled 7 days or less prior to the first night stay the fee will be equivalent to one night stay at reserved facility. If reservation cannot be granted, full payment will be returned.

No more than two vehicles (including trailers) may be parked at a camping facility or site. Additional vehicles may be parked in a location designated by the area superintendent at a fee of \$5/vehicle.

Applicants must be 18 years of age or older. Alcoholic beverages and pets are not permitted in overnight or camping facilities.
