Environmental Projects

Fee (Not to Exceed): \$125,000.00

Environmental contamination has been discovered on a parcel of property that was acquired by the Authority in conjunction with the Route 92 project. The contamination extends onto the adjacent parcel that is owned by the Matrix Development Corporation. Matrix is in the process of remediating the contamination on their property and it has been determined that it would be cost effective to remediate the Authority's property simultaneously, with Matrix taking the lead and the Authority reimbursing Matrix for the portion of the cleanup involving the Authority's parcel. In May 2007 the Executive Director authorized reimbursement to Matrix in an amount up to \$25,000 under delegated authority to undertake investigations necessary to define the physical limits and composition of the contamination. The Executive Director authorized an additional \$10,000 for these efforts in April of 2010, increasing the authorized reimbursement amount to \$35,000. Based on the results of the subject investigation it has been determined that the Authority's share of the actual remediation of the contamination will be in an amount not to exceed \$125,000.
